**E-AUCTION SALE NOTICE**

**SALE OF IMMOVABLE PROPERTY MORTGAGED TO THE BANK UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT, 2002**

Whereas **Mrs. N.B Sindhuja & Late. Mr. N R Boopathy** has borrowed monies from Indian Overseas Bank against the mortgage of the immovable properties more fully described in the schedule hereunder and on upon classification of the account as NPA, the Bank has issued a demand notice under Section 13(2) of the SARFAESI Act, 2002 (Act) on **03.02.2023** calling upon the borrower/mortgagor **1) Mrs. N. Boopathy all residing at No. 1/227, Middle Street, Sivan Kovil Street, Natham Village and Post, Thottiam Taluk, Tiruchirappalli District Also at 10/12, Indra Nagar, 3<sup>rd</sup> Street, Medical College Road, Thanjavur – 631 007 to pay the amount due to the Bank, being Rs. 70,34,636/56 (Seventy lakhs thirty four thousand six hundred thirty six and paise fifty six only) as on 03.02.2023 payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment within 60 days from the date of receipt of the said notice.

Whereas the borrowers having failed to pay the amount dues in full to the Bank as called for in the said demand notice, the Bank has taken possession of the secured assets more fully described in the schedule hereunder on **30.05.2023** under Section 13 (4) of the Act with the right to sell the same in "As is where is" and "As is what is" basis under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking possession was intimated as Rs. 73,08,879/06 (Seventy three lakhs eight thousand eight hundred seventy nine and paise six only) as on 30.05.2023 payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower as on 30.01.2026 works out to **Rs. 83,67,711/-** (Rupees Eighty three lakhs sixty seven thousand seven hundred and eleven only), after reckoning repayments, Rs. 20,00,006/-, subsequent to the Bank issuing demand notice.

The undersigned in exercise of the powers conferred under Sec 13(4) of the said Act proposes to realize the Bank's dues by sale of the under mentioned properties.

### Terms and Conditions

1. The property(ies) will be sold by e-auction through the service provider PSB Alliance in BAANKNET(Bank Asset Auction Network) (URL: <https://baanknet.com/>) under the supervision of the of The Authorized Officer of the Bank.
2. The intending Bidders /Purchasers are requested to register on portal <https://baanknet.com/eauction-psb/bidder-registration> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account by **20.02.2026 before 3.00 PM**. Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.
3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through Net Banking/NEFT/RTGS mode in <https://baanknet.com/>. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. Bids without EMD shall be rejected summarily. The Earnest Money Deposited shall not bear any interest. The amount of EMD paid by the successful bidder shall be adjusted towards the sale price.
